RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT PARTICIPATION IN VOLUNTEER ACTIVITIES

In consideration of being permitted to participate in any volunteer activities of the Valley Springs Motorcycle Club, Inc. (the "Club") including, but not limited to, preparation of the grounds, clearing of hills, trails and brush, or the driving of any Club vehicle, or the use of any equipment or tools supplied by the Club in connection with such activities (collectively, "Volunteer Activities" and individually, a "Volunteer Activity"), the undersigned, for himself or herself and any personal representatives and heirs, hereby acknowledges, agrees and represents that he or she has or immediately upon entering any property will inspect the said property or premises and the vehicles, tools and equipment to be used in such activities. It is further warranted that such entry into or onto such property or premises for participation in Volunteer Activities and the use of any tools or equipment in connection with Volunteer Activities shall constitute an acknowledgment that such property and the tools and equipment to be used have been inspected and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such use. The undersigned further acknowledges that he or she is aware of the inherent dangers and of the basic safety rules for all the activities conducted in connection with Volunteer Activities.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN THE VOLUNTEER ACTIVITIES OF THE CLUB FOR OR USE OF VEHICLES, TOOLS OR EQUIPMENT IN CONNECTION WITH THE VOLUNTEER ACTIVITIES IN ANY WAY, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. The undersigned hereby releases, waives, discharges and covenants not to institute or prosecute any lawsuit against the Club, or any of its directors, officers, employees, members or landowner or owners, lessor or lessee, agents and any and all co-sponsors from all liability to the undersigned for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence by the Club or otherwise, while the undersigned is participating in Volunteer Activities or using the vehicles, tools or equipment by the Club in connection of any Volunteer Activity.
2. The undersigned hereby agrees to indemnify and save and hold harmless the Club, or any of its directors, officers, employees, members or landowner or owners, lessor or lessee, agents and any and all co-sponsors from any loss, liability, damage or cost the Club may incur due to the presence of the undersigned while the undersigned is participating in a Volunteer Activity or using the vehicles, tools or equipment by the Club in connection of any Volunteer Activity whether caused by the negligence by the Club or otherwise.
3. The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence by the Club or otherwise, while the undersigned is participating in Volunteer Activities or using the vehicles, tools or equipment by the Club in connection of any Volunteer Activity.

The undersigned further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Wisconsin that if any portion thereof is held invalid, it is agreed that the remainder shall continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no representations, statements and inducements apart from the foregoing written statement have been made.

THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT SHALL BE EFFECTIVE FOR THE PERIOD OF:
